Summary of the proceedings of the 13th Extra-Ordinary General Meeting (EGM) of Auxilo Finserve Private Limited

The EGM of Auxilo Finserve Private Limited was held on Monday, 11th December, 2023 at 4:38 PM (IST) through Video Conferencing / Other Audit Visual Mode. The Company, while conducting the Meeting, adhered to the Circulars issued by the Ministry of Corporate Affairs ("MCA"), the Securities and Exchange Board of India ("SEBI"). The proceedings of the EGM were deemed to be conducted at the Registered Office of the Company which was the deemed Venue of the EGM.

9 members (including 4 authorised representatives) were present at the meeting.

Mr. Manish Chokhani, Chairman of the Board chaired the Meeting.
